The following 7D vehicle equipment is required and must pass the pre-registration inspection before registering the vehicle.

- Vehicle can have a maximum 11 seats including the operator.
- Vehicle must be a passenger vehicle with a gross vehicle weight rating of 10,000 pounds or less
- All vehicles 2018 or newer must have a child reminder system
- Lighting: headlights (low and high beam), directional (front and rear), brake lights, reverse lights, plate lights
- Brakes: service and parking
- Exhaust system, no fluid leaks
- "School Bus" sign (8" black lettering on front & rear)
- Front and rear alternating flashing "School Bus" red signal lamps
- Emergency buzzer or warning light to alert of any open door, working horn
- Fire extinguisher and mounting (rating of 2A10BC or greater with hose)
- First aid kit (sufficiently stocked for expected vehicle occupancy)
- Three (3) flares meeting U.S. Federal Motor Vehicle Safety Standards #125
- Two (2) chock blocks
- Two (2) operational windshield wipers
- All tires must have a minimum tread depth of 4/32"
- Body fluid clean up kit
- Seat belt cutter
- Fire/evacuation blanket for wheel chair vehicles only
- Vehicles must have an interior school bus light indicator
- Vehicles must have an audible back-up alarm
- Seat belt for each permanent seat including operator's seat, designed and installed per U.S. Federal Motor Vehicle Safety Standards
- Both sides of vehicle have the company name, city, state visibly displayed in lettering at least two inches high and in a contrasting color, mirrors
